### Rules / Guidelines to Students for applying Scholarships / Freeships

- 1) Students should apply only in prescribed application form available with Shree Ramnath Devasthan Charities.
- 2) All columns should be filled carefully and correctly only in English.
- 3) Correct information should be furnished. Application will not be considered if incomplete /incorrect information is given.
- 4) Application forms shall be issued up to **31st August each year**. Application complete in all respect should reach Shree Ramnath Devasthan Charities on or before **30th September each year**. Late / belated submission of Application Forms beyond scheduled dates shall not be considered for grant a Scholarship.
- 5) Every year new Application Form is to be filled, if the student desires to avail of facility of Scholarship / Freeship.
- 6) The Application Form shall be accompanied by copies of mark lists, passing certificate issued by recognised Universities. Income Certificate issued by Mamlatdar / Revenue Officer of concerned Taluka only in English language. Translated copy if it is issued in vernacular language duly attested by Mamlatdar Revenue officer of concerned Taluka and 1<sup>st</sup> page of Bank Pass Book.
- 7) Student whose annual result is not declared and desires to apply for Scholarship / Freeship should do so and send the marksheets as soon as result is declared but not later than **30th September each year**. The student however shall give his Seat No. class of study, examination Centre, Name of University for which he had appeared.
- 8) Scholarship / Freeship shall be granted to Meritorious students who scores on an average 60% and above marks in **1st/ 2nd/ 3rd/ 4th** year of a degree course in the branch of Arts, Science, Commerce, Business Administration, Computer Application, Medicine, Dentistry, Pharmacy, Architecture, Engineering conducted by any recognized University and whose annual family income from all sources does not exceed **Rs. 2,50,000/- per annum** as certified by Mamlatdar / Revenue Officer of concerned Taluka.
- 9) Students shall not be entitled to any scholarship / freeships for fall in their performance during subsequent years.
- 10) This Scholarship / Freeship is available to deserving and eligible students irrespective of caste, creed and religion.
- 11) Student fulfilling / satisfying above Rules / Guidelines may only apply. Mere submission of an application by a student shall not confer any right on the student to grant of Scholarship / Freeship.
- 12) Shree Ramnath Devasthan Charities shall have the absolute right of accepting / rejecting any / all application without assigning any reasons whatsoever and no correspondence in this regard shall be entertained.
- 13) After completion of studies a letter of completion with Principal's certificate should be produced to the Charities.
